PROHIBITION ON PUBLIC RELEASE OF NAME OF 2 FEDERAL LAW ENFORCEMENT OFFICER. 3 (a) IN GENERAL.—Section 1510 of title 18, United 4 States Code, is amended— 5 (1) in the heading, by inserting "and immi-6 gration enforcement operations" after "criminal investigations"; and 7 8 (2) by adding at the end the following: 9 "(f) Releasing Name of Federal Law Enforce-10 MENT OFFICER.— 11 "(1) DEFINITION.—In this section, the term 12 'Federal law enforcement officer' means any officer, 13 agent, or employee of the United States authorized 14 by law or by a Government agency to engage in or 15 supervise the prevention, detection, investigation, or 16 prosecution of any violation of Federal criminal law 17 or immigration law. 18 "(2) OFFENSE.—It shall be unlawful to make 19 the name of a Federal law enforcement officer pub-20 licly available with the intent to obstruct a criminal 21 investigation or immigration enforcement operation. 22 "(3) PENALTY.—Any person who violates para-23 graph (2) shall be fined under this title, imprisoned 24 for not more than 5 years, or both.". 25 (b) TECHNICAL AND CONFORMING AMENDMENTS.— 3
