7	(b) Policy Recommendations.—Not later than
8	180 days after the date of submission of the report under

10	opment shall submit to Congress a report that includes—
11	(1) recommendations for improving the trans-
12	parency of foreign ownership in residential property
13	transactions in the United States;
14	(2) recommendations for protecting access to
15	residential real estate transactions for residents of
16	the United States; and
17	(3) any legislative or regulatory actions deter-
18	mined necessary to carry out the recommendations
19	described in paragraph (1) and (2).
